- **Community Engagement:** The camp fostered community participation in legal empowerment initiatives.

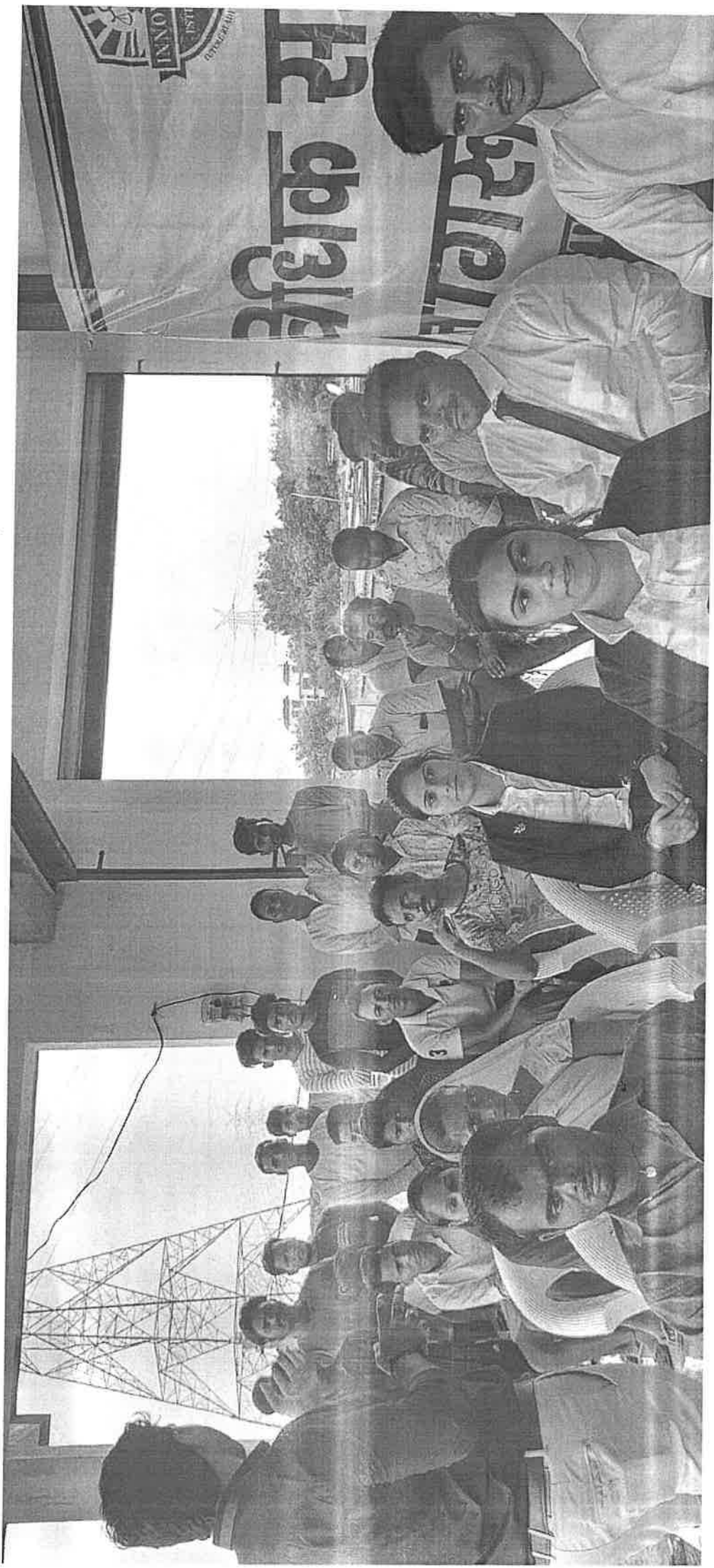
#### **Future Recommendations:**

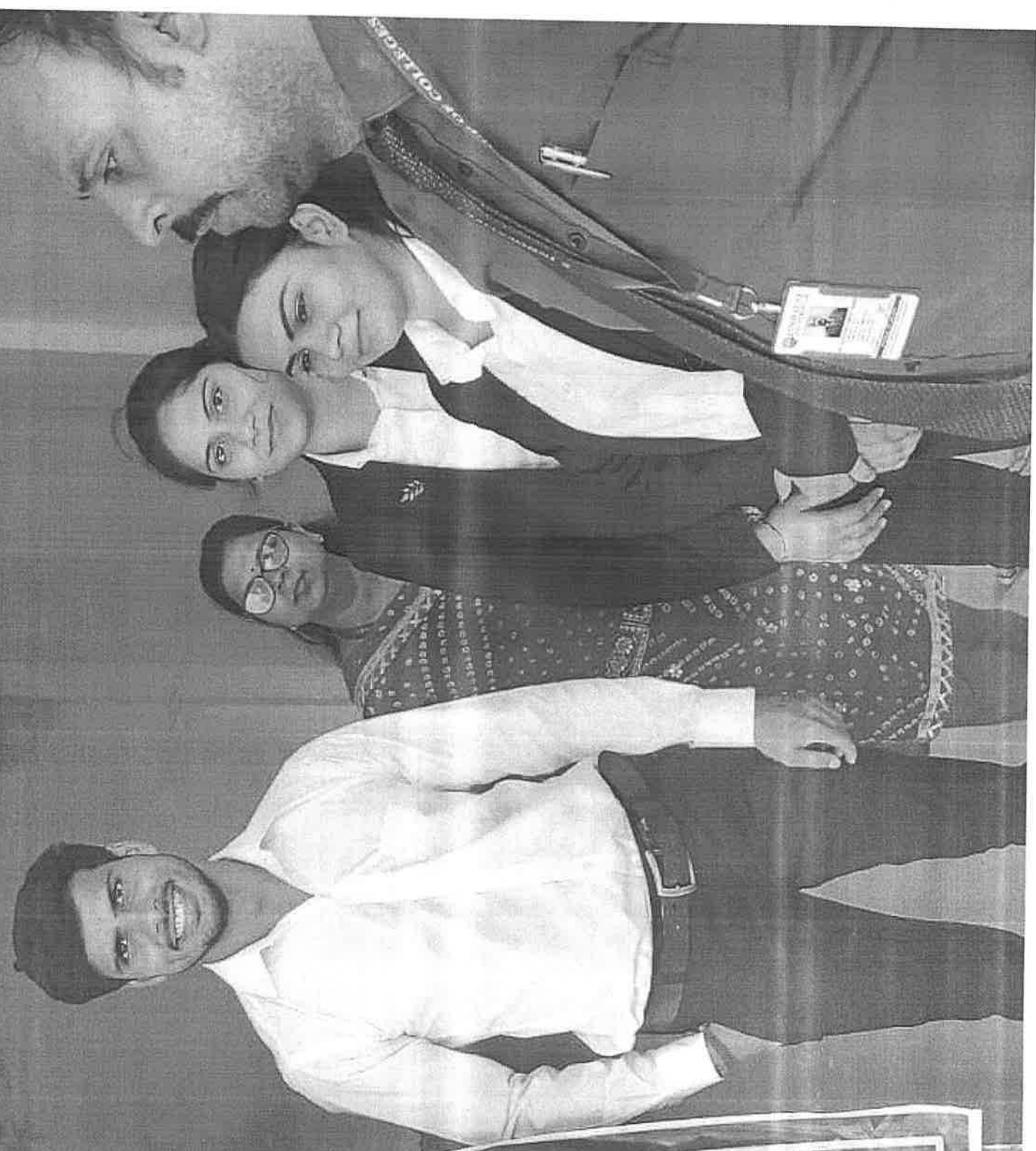


