Report Youth Day Celebration

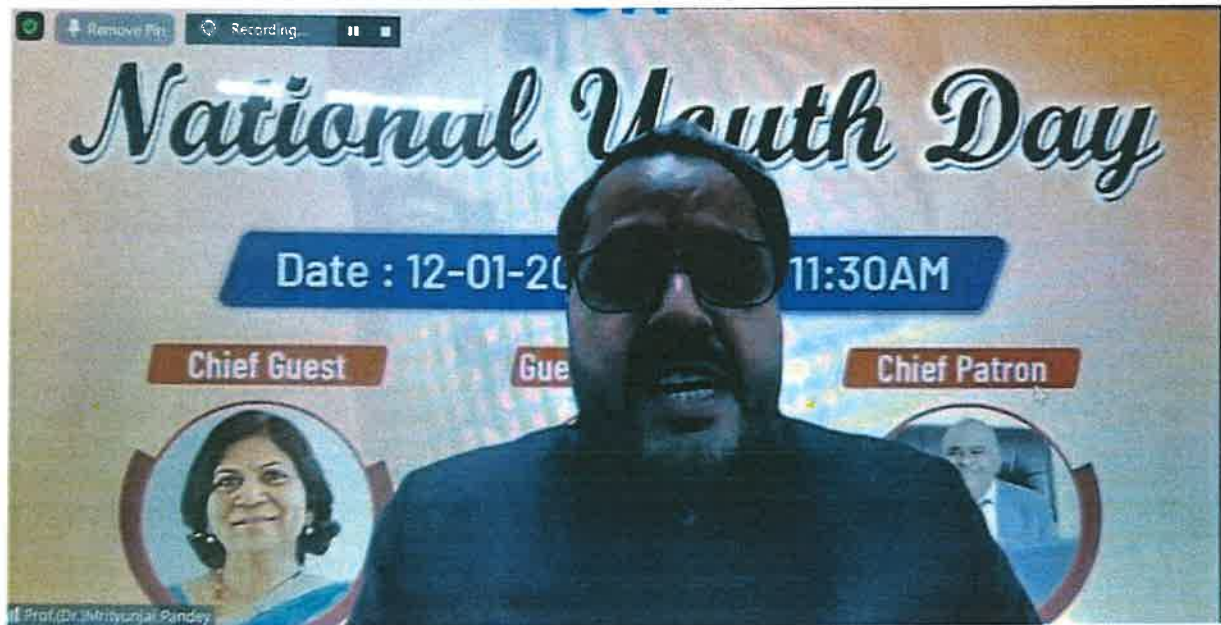
