Feedback from participants was overwhelmingly positive, with many expressing appreciation for the clarity and usefulness of the information presented. Attendees highlighted the practical nature of the session, noting that the tips and techniques shared would greatly improve their virtual communication skills.

Given the increasing reliance on remote collaboration, such initiatives are essential for improving digital literacy and ensuring that participants are well-equipped to handle virtual meetings. It is recommended that similar sessions be conducted periodically to keep participants updated on evolving tools and best practices. Future sessions could also cover advanced features of Zoom and explore other digital platforms to provide a comprehensive understanding of available communication tools.
