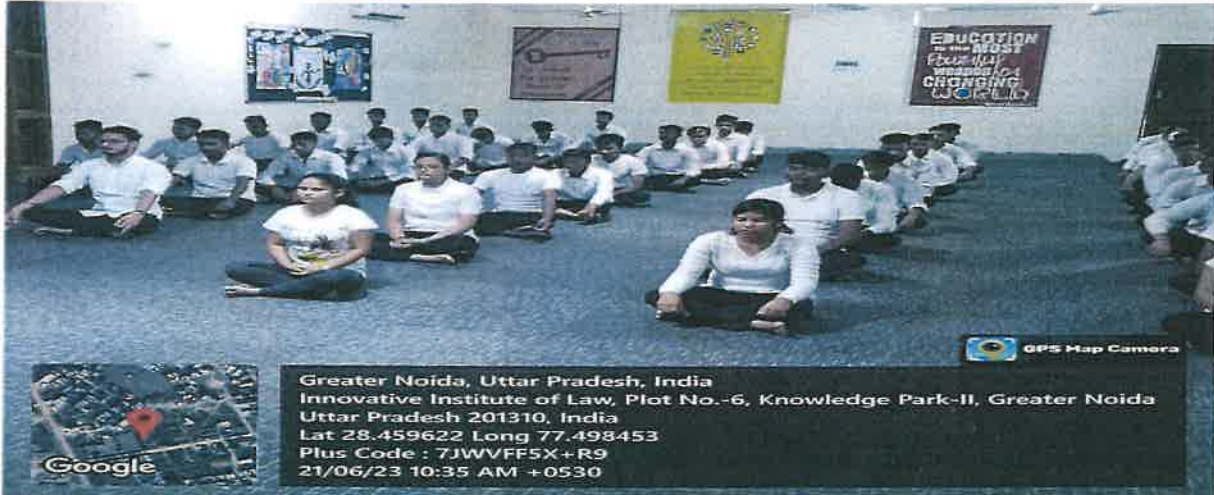
Conclusion:
