



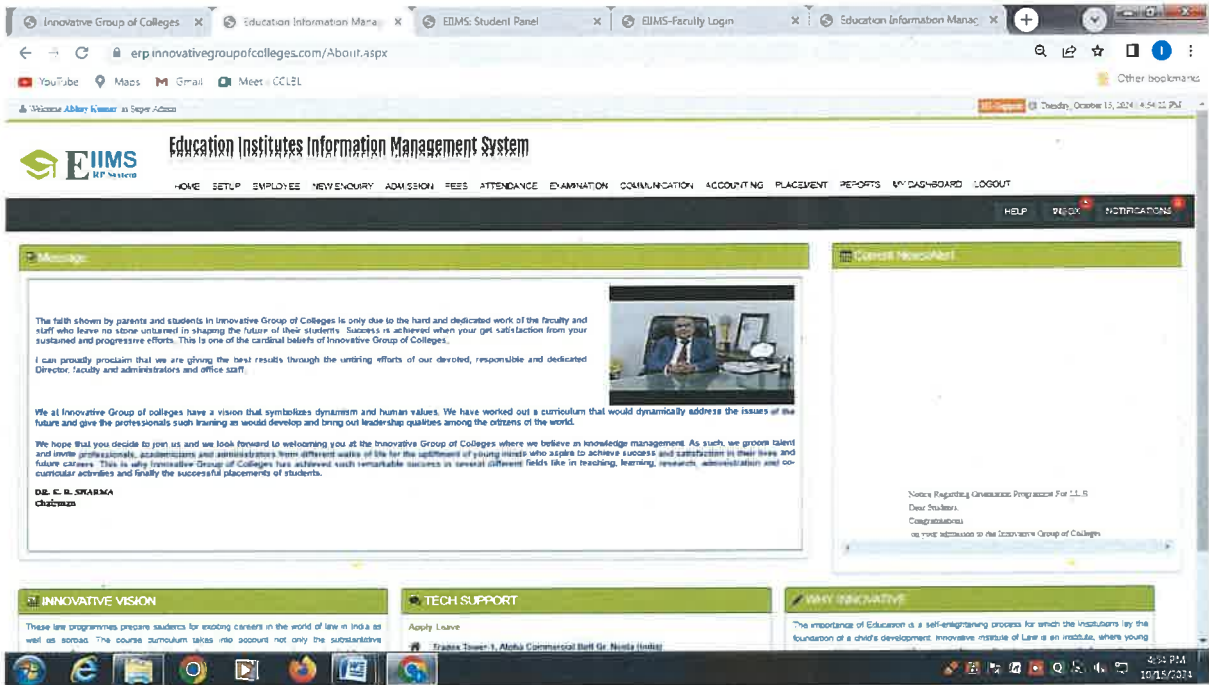

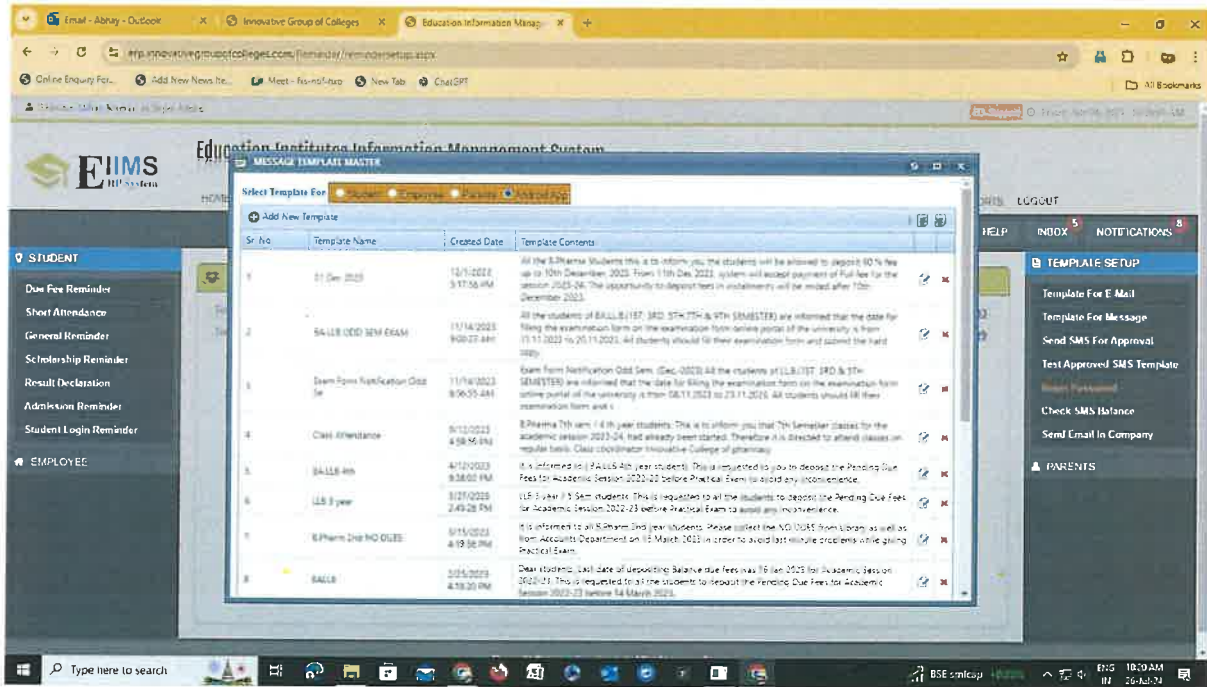


Figure 2- Faculty Leave Application

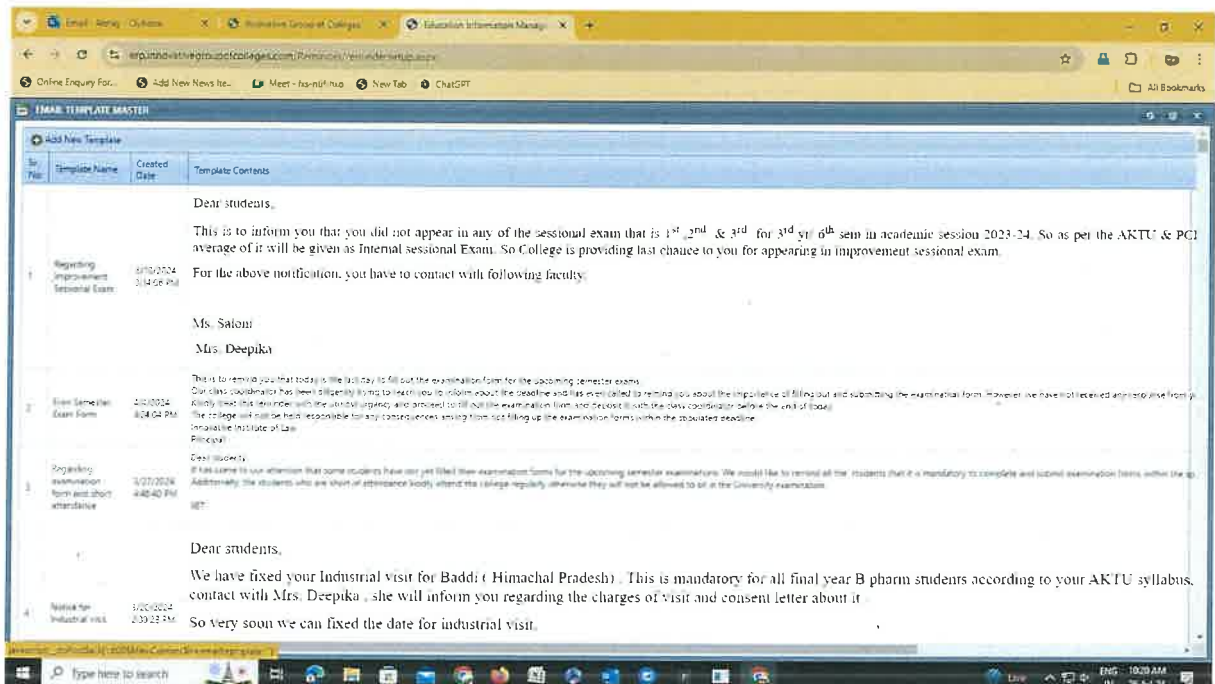


Figure 3- Students sent SMS Reports

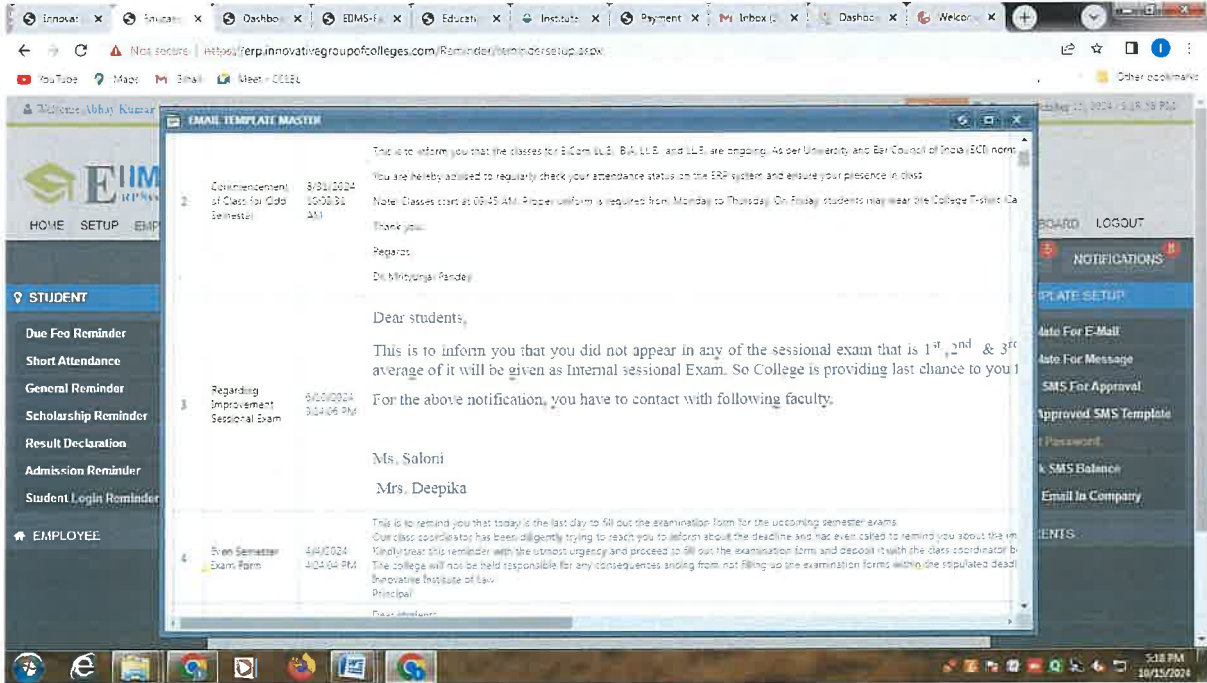


Figure 4- Sent E-mail Reports

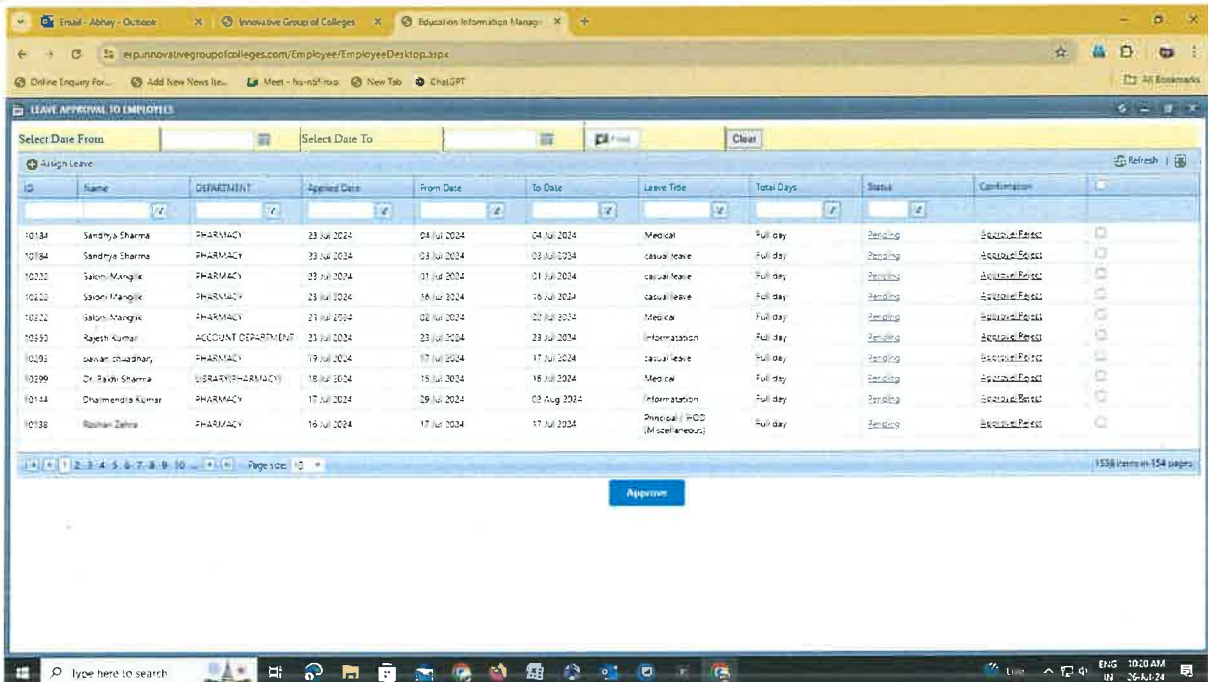


Figure 5- Staff Leave on College ERP Software

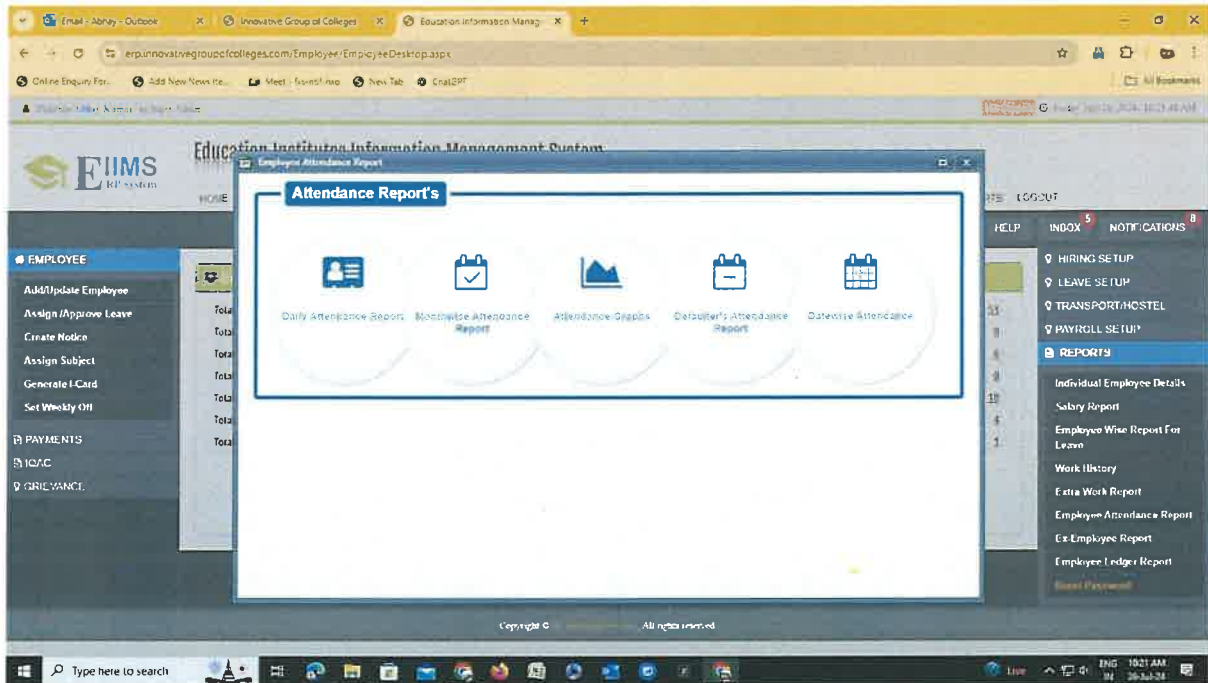


Figure 6- Staff Attendance Sheet on College ERP Software

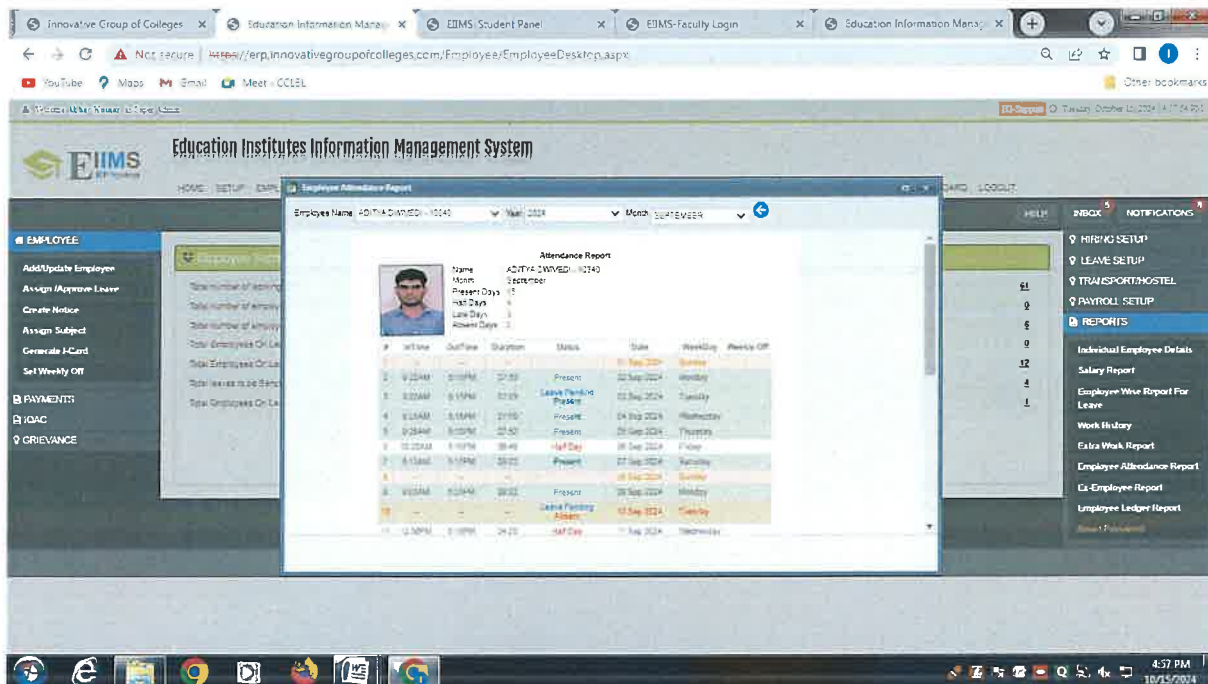


Figure 7- Staff Monthly Attendance Sheet on College ERP Software

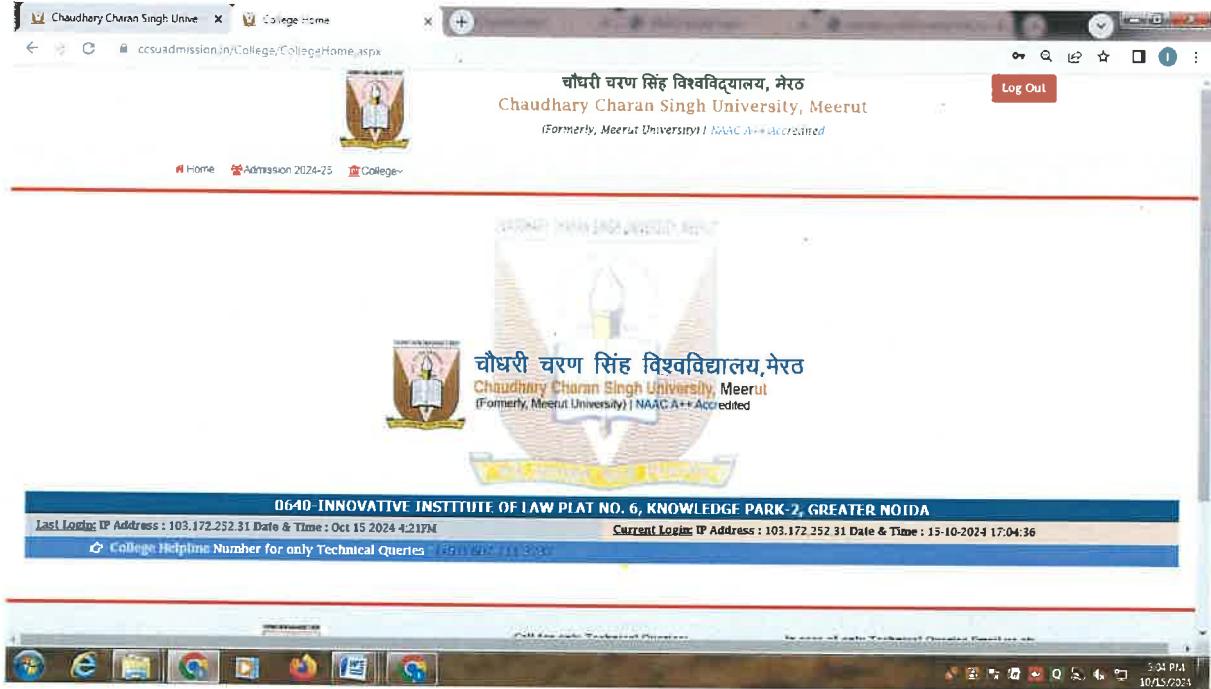

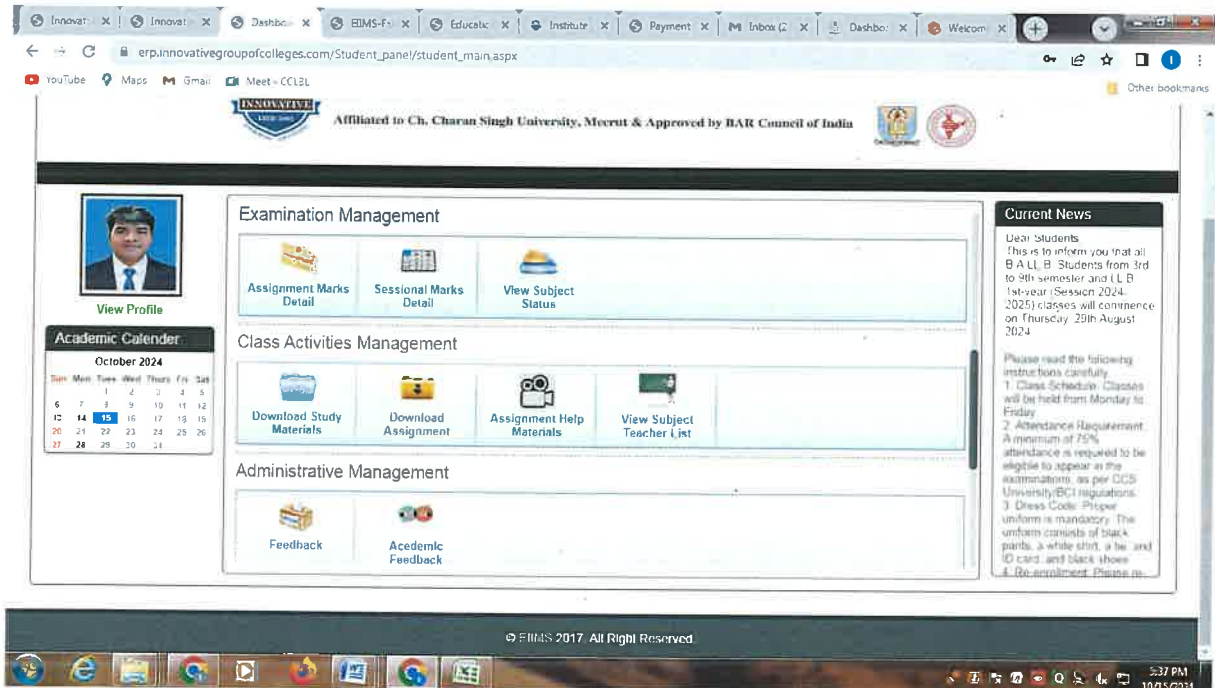


Figure 1- Details of Scholar form on ERP Software

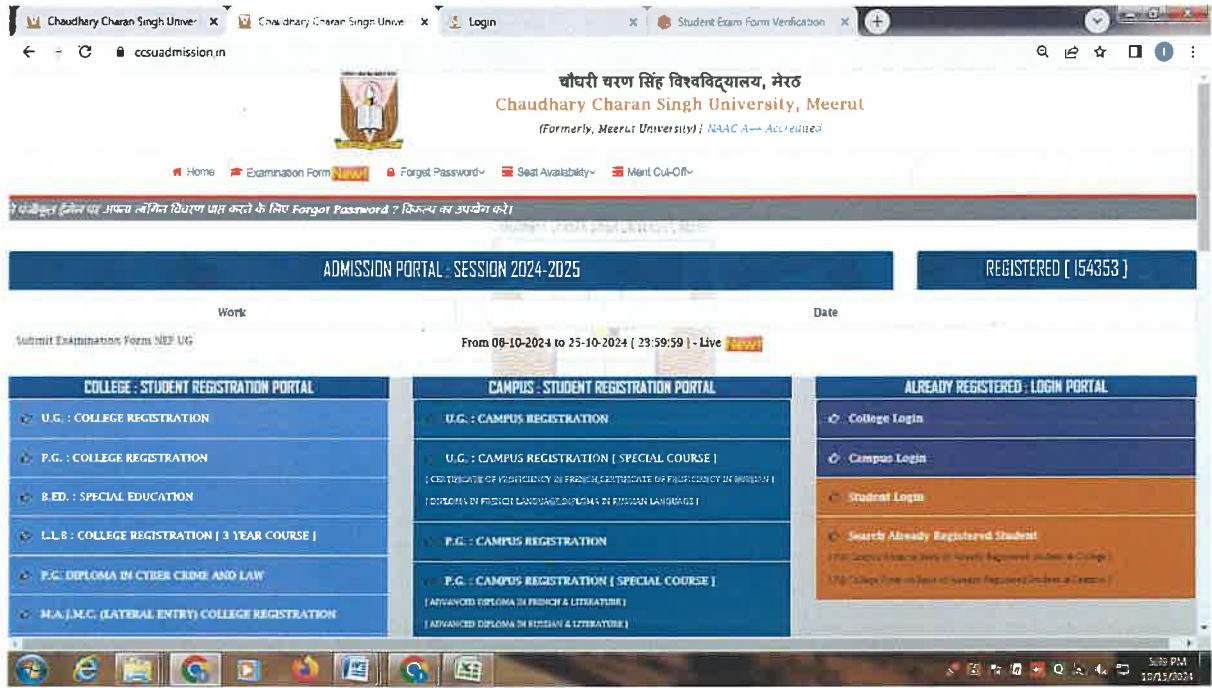


Figure 2- Details of Admission form on CCS University

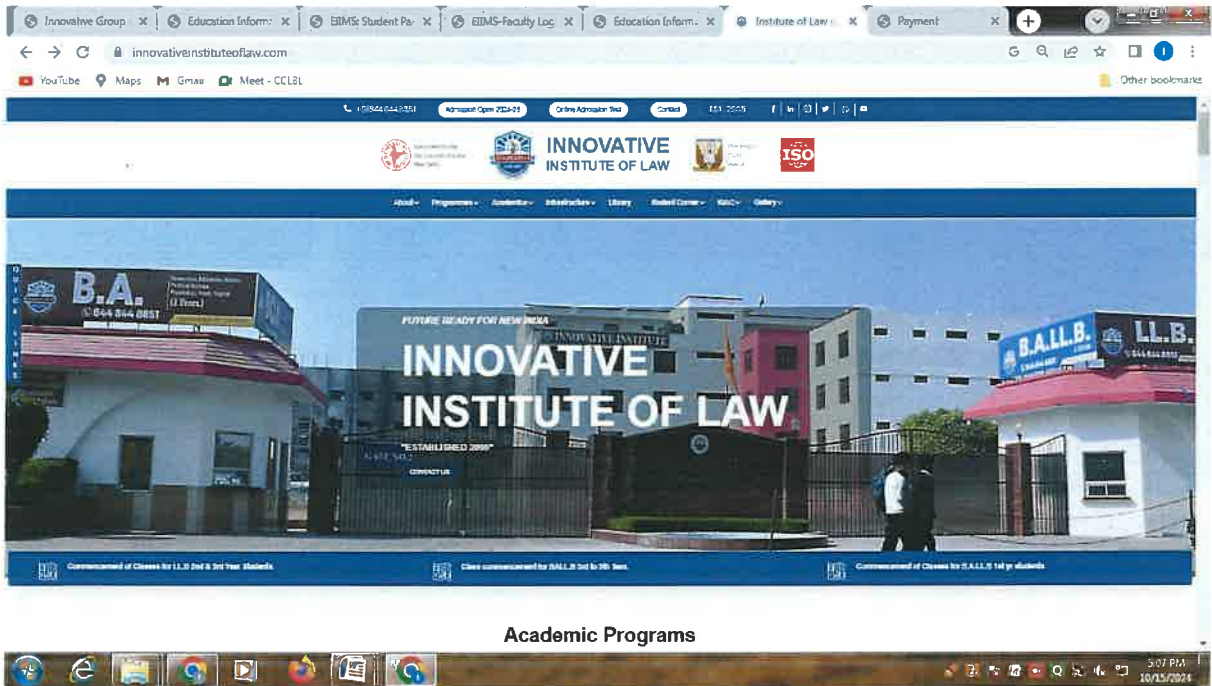


Figure 3- Online Admission portal on College Website

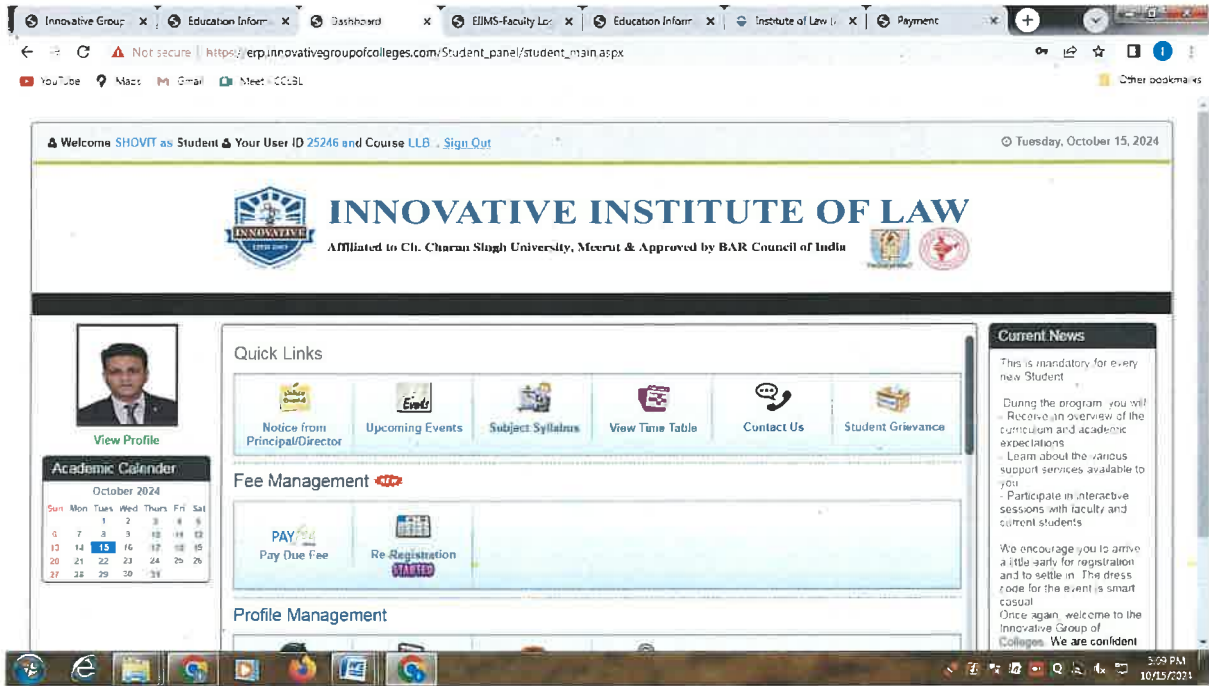


Figure 4- Admission fees deposit portal on College ERP

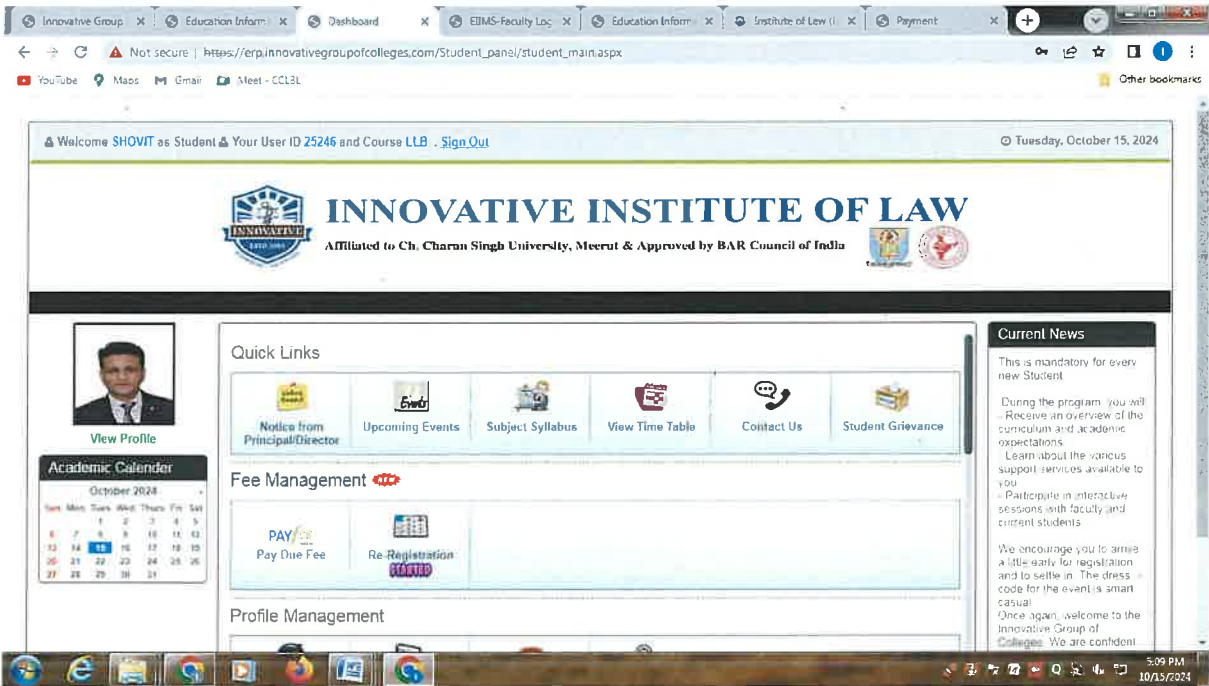


Figure 5- Fees deposit portal on College ERP

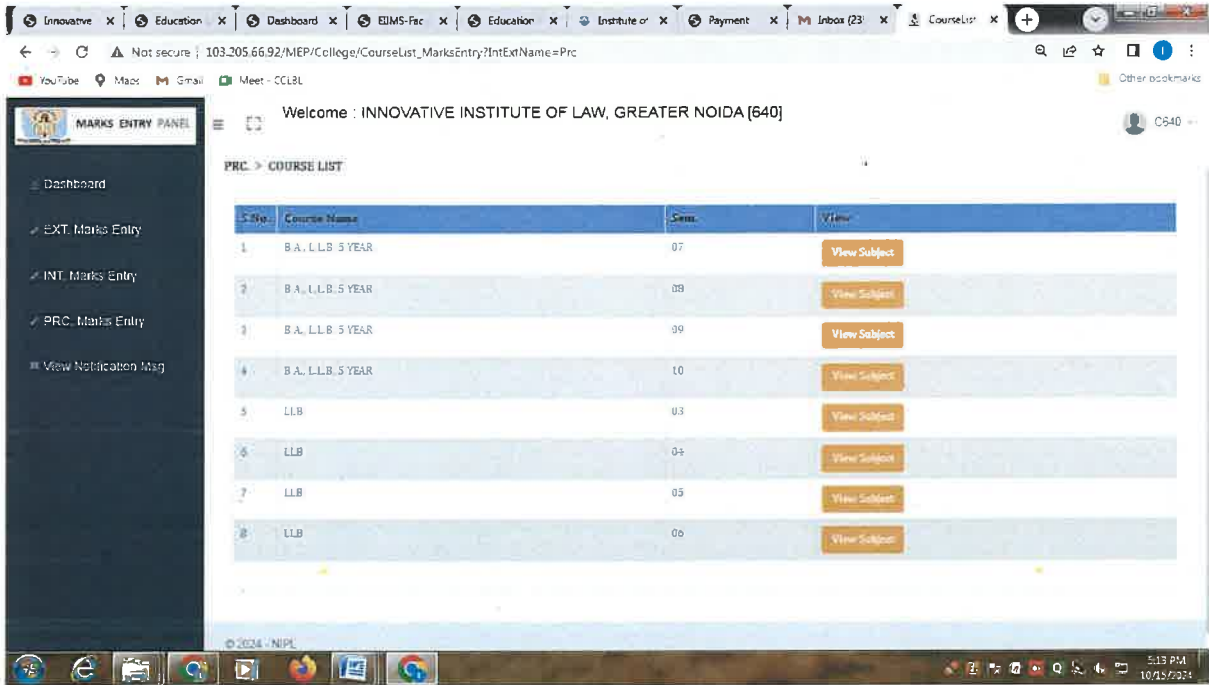


Figure 2- Students Award Sheet for Practical Exams

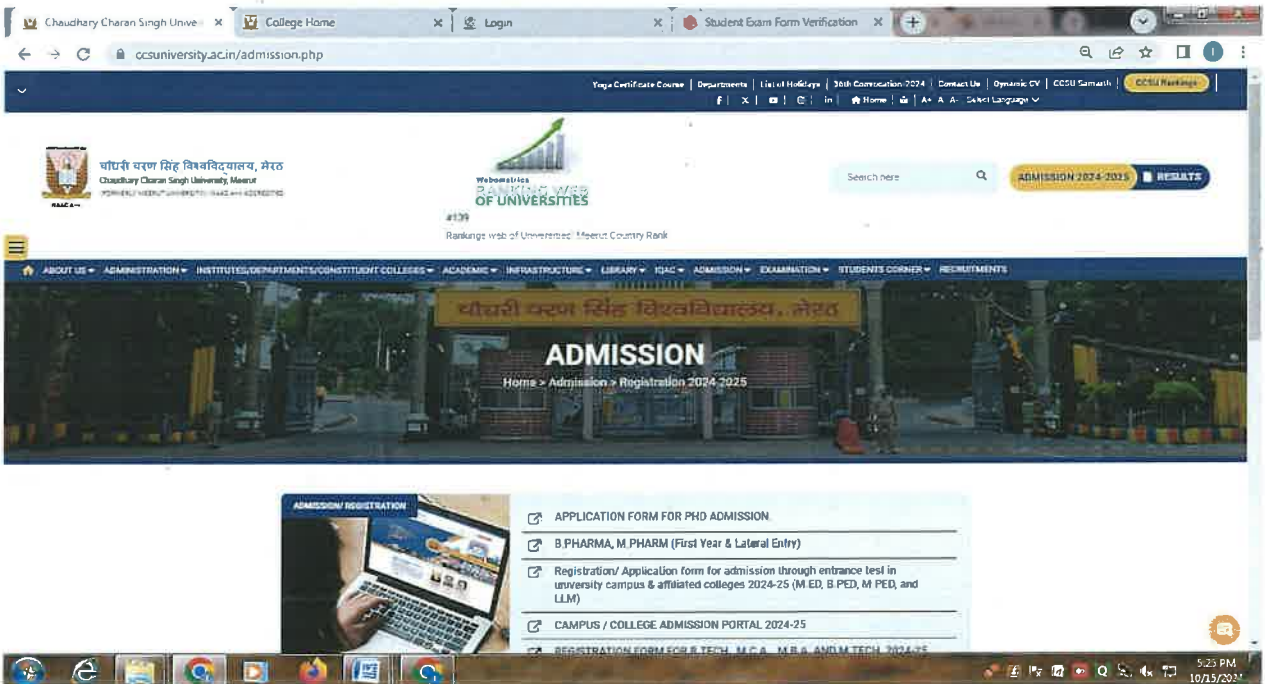


Figure 3- CCS University ERP for University Work

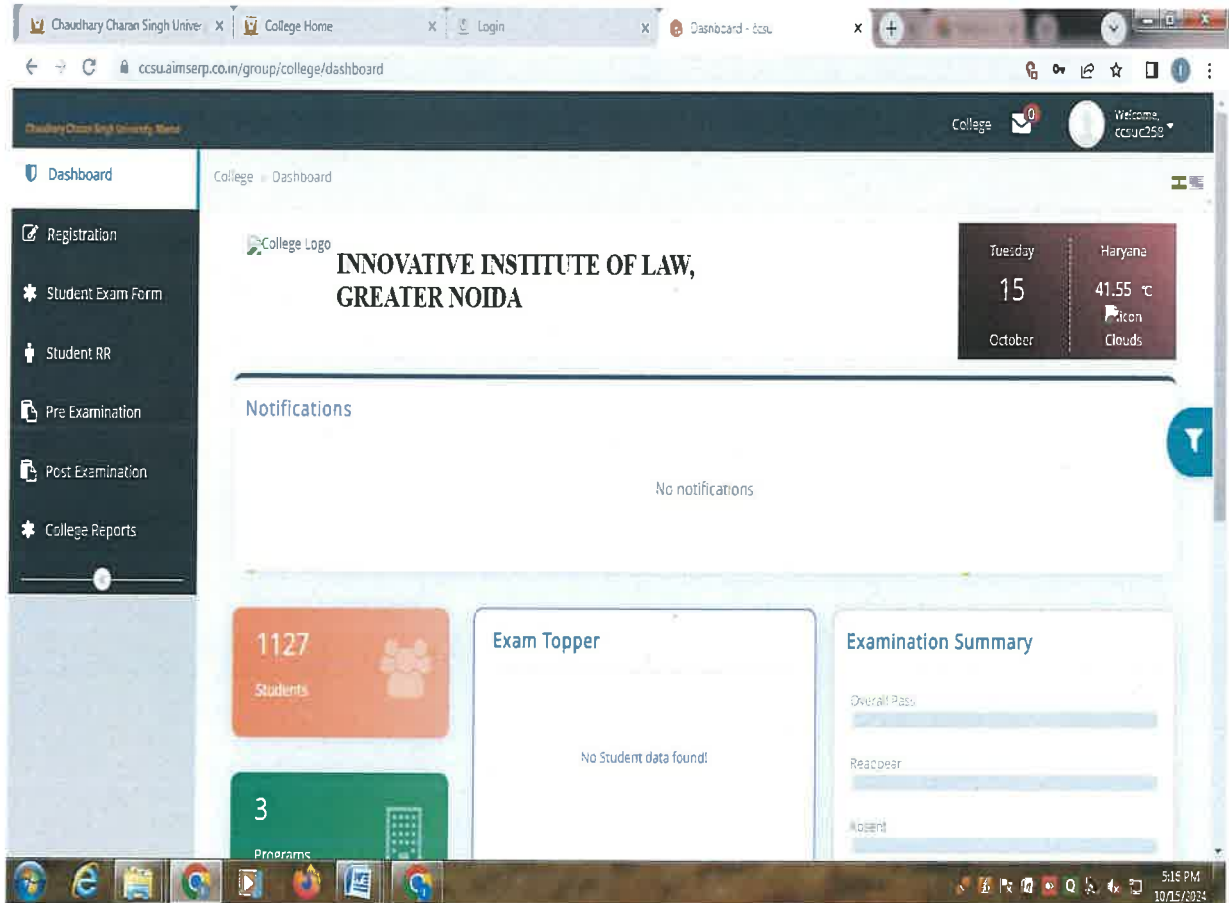



Figure 4- Students Examination Form on CCS University ERP
